**A Resolution declaring ORIENT STAR CONSTRUCTION, INC. as the Second Lowest Calculated Bidder for the project MPF-PLW-02-2020 Various Maintenance of Port Physical Facilities (Phase II), Port of Puerto Princesa, Palawan and Recommending Approval Thereof and Recommending Award of Contract.**

WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/ posted the Invitation to Bid for the project MPF-PLW-02-2020 Various Maintenance of Port Physical Facilities (Phase II), Port of Puerto Princesa, Palawan in the PhilGEPS and PPA websites, and at bulletin board of PMO- Palawan continuously for seven (7) days from August 14- 20, 2020;

WHEREAS, in response to the said advertisement, three (3) prospective bidders bought the Official Bid Documents at 5,000.00 each:

- 1). ORIENT STAR CONSTRUCTION, INC.
- 2). EM ABIN TRADING & CONSTRUCTION
- 3). RD ABACIAL CONSTRUCTION

WHEREAS, on the scheduled Submission and Opening of Bids, only two (2) contractors/ bidders submitted their bids, namely:

- 1). ORIENT STAR CONSTRUCTION, INC., September 4, 2020 at 4:38 P.M.
- 2). RD ABACIAL CONSTRUCTION, September 7, 2020 at 8:48 A.M.

WHEREAS, at 10:00 A.M. on September 07, 2020 the Technical Bids of *ORIENT STAR CONSTRUCTION, INC.* and *RD ABACIAL CONSTRUCTION* were opened and both passed the preliminary examination. After which, the Financial Bids were opened and also passed the preliminary examination, and the result of their Financial Bids are tabulated as follows:

WHEREAS, the detailed evaluation of bid, conducted at 3:00 P.M. on September 8, 2020 resulted in the following:

WHEREAS, the Bids and Awards Committee (BAC) declared the Bid of RD Abacial Construction as the Lowest Calculated Bid;

WHEREAS, upon careful examination, verification, validation, and ascertainment of all statements and representations made, including all documents submitted, the Technical Working Group (TWG) found that the bidder failed to comply with, and be responsive to, the requirements and conditions specified in the Bidding Documents, based on the following grounds:

List of Contractor's Equipments Ref.: 1. Section 34.3, (b.ii) of 2016 Revised IRR of RA 9184 2. GPPB Circular No. 03-2012	Failure to present the Concrete Cutter and Air Compressor with Jackhammer during the inspection/verification of equipment pledged to the project on September 15, 2020.
	Failure to submit the LTO OR/ CR of the Elf Truck to verify the registration, ownership and capacity of the equipment as pledged.
	Failure to submit the OR or any document of the Road Roller to verify the ownership and capacity of the equipment as pledged.


WHEREAS, during the Post-Qualification Conference on September 16, 2020 at 3:00 P.M., the BAC unanimously agreed to disqualify RD ABACIAL CONSTRUCTION due to the above findings, and therefore, scheduled the post-qualification to the second (2<sup>nd</sup>) lowest calculated bidder, the ORIENT STAR CONSTRUCTION, INC.;

WHEREAS, a corresponding post qualification was conducted by the PMO Palawan BAC-TWG on September 18-22, 2020;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical/project and financial requirements submitted by *ORIENT STAR CONSTRUCTION, INC.*, its bid has been found to be responsive pursuant to RA 9184 and its 2016 Revised IRR and Latest GPPB Issuances;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for the Procurement of Goods and Consultancy Services and for Engineering Projects (PMO-PALAWAN-BAC), hereby RESOLVE as it is hereby RESOLVED:

- a) To declare ORIENT STAR CONSTRUCTION, INC. as the Lowest Calculated Responsive Bidder for the project MPF-PLW-02-2020 Various Maintenance of Port Physical Facilities (Phase II), Port of Puerto Princesa, Palawan;



- b) To recommend for approval by the Acting Port Manager/Head of the Procuring Entity (HOPE) of PMO- Palawan the foregoing findings; and
- c) To recommend award of contract of the subject project to ORIENT STAR CONSTRUCTION, INC. in its submitted bid amount of Php 1,833,125.44
