Declaring the Bid of JC PIÑON CONSTRUCTION, INC. as the Single Calculated Responsive Bid for the project NRP-PLW-01-2017 Repair of Damaged R.C. Wharf Deck/Slab, Concrete Pavement and Damaged/Settled Paving Blocks, Shear Key and Retaining Wall, Port of Puerto Princesa, Palawan, and Recommending Approval Thereof and Recommending Award of Contract

WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised the Invitation to Bid for the project NRP-PLW-01-2017 Repair of Damaged R.C. Wharf Deck/Slab, Concrete Pavement and Damaged/Settled Paving Blocks, Shear Key and Retaining Wall, Port of Puerto Princesa, Palawan in Manila Times on September 6, 2017 and posted in PhilGEPS and PPA websites and at the bulletin board of PMO-Palawan continuously for seven days from September 6 to 12, 2017;

WHEREAS, in response to said advertisement, two (2) prospective bidders purchased bidding documents, namely:

- 1.) JC PIÑON CONSTRUCTION INC.
- 2.) BCT TRADING AND CONSTRUCTION

WHEREAS, both the contractors/bidders submitted their bids in sealed envelope within published deadline;

WHEREAS, at 9:12 A.M. on September 25, 2017 the Technical Bid of JC PIÑON CONSTRUCTION INC. was opened and passed the preliminary examination. After which, the Financial Bids was opened and also passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:

WHEREAS, at 9:39 A.M. on September 25, 2017, the Technical Bid of BCT TRADING AND CONSTRUCTION was opened and failed the Eligibility and Technical/Project Requirement due to the following reasons:

- Eligibility Requirements:
- On Bid Form IX (Breakdown of Major Categories of Work of Prospective Bidder's Completed Contract Similar to Contract to be Bid), the Similar Major Categories of Work submitted by the bidder on Item 1. "Excavation/Disposal" is not similar with the required Major Categories of Work (Experience Required) which is "Demolition and Disposal of Damaged R.C. Wharf Deck/Slab".
- Technical /Project Requirements:
- The required "Jack Hammer" was not included in the list of Equipment Pledged to the Contract nor in the Certification of Availability of Equipment submitted by the bidder.

WHEREAS, the detailed evaluation of bid conducted at 9:04 A.M. on September 26, 2017 resulted in the following:
