**A Resolution declaring JULRIZ Construction & Supply as the Single Calculated  
Responsive Bidder for the project MPF-PLW-03-2022 Various Maintenance of Port  
Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan and  
Recommending Approval Thereof and Recommending Award of Contract.**

WHEREAS, the Philippine Ports Authority, PMO-Palawan posted an Invitation to Bid for the project MPF-PLW-03-2022 Various Maintenance of Port Physical Facilities Port of Brooke's Point, Brooke's Point, Palawan, in the website of the PPA, PhilGEPS and in the Bulletin Board of PMO-Palawan on 5 September 2022, continuously for seven (7) calendar days.

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 1,159,720.30**.

WHEREAS, in response to the said advertisement/invitation for negotiation, one (1) prospective bidder responded with the invitation, namely:

1). JULRIZ Construction & Supply

WHEREAS, the contractor/ bidder submitted their bid in sealed envelope with published deadline;

WHEREAS, at 10:00 A.M. on 27 September 2022 the Technical Bid of JULRIZ Construction & Supply was opened and passed the preliminary examination. After which, the Financial Bid was opened and also passed the preliminary examination and the result of the Financial Bid is tabulated as follows:

NOW THEREFORE, for and in consideration of the foregoing premises, the PMO-Palawan Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To declare JULRIZ Construction & Supply as the bidder with the Single Calculated Responsive Bid for the project MPF-PLW-03-2022 Various Maintenance of Port Facilities, Port of Brooke's Point, Brooke's Point, Palawan;
2. To recommend for approval by the Port Manager/Head of the Procuring Entity (HOPE) of PMO- Palawan the foregoing findings; and
3. To recommend award of contract of the subject project to JULRIZ Construction & Supply in its submitted bid amount of **One Million One Hundred Fifty-Seven Thousand Five Hundred Thirteen Pesos and Thirty-Seven Centavos (Php 1,157,513.37)**.
