Resolution No. 15 Series of 2023

A Resolution declaring Giant MaPhil Construction as the Lowest Calculated Bidder for the project MPF-PLW-04-2023 Maintenance of Various Port Physical Facilities, Port of Coron, Coron, Palawan and Recommending Approval Thereof and Recommending Award of Contract.

WHEREAS, the Philippine Ports Authority, PMO-Palawan posted an Invitation to Bid for the project MPF-PLW-04-2023 Maintenance of Various Port Physical Facilities, Port of Coron, Coron, Palawan, in the website of the PPA, PhilGEPS and in the Bulletin Board of PMO-Palawan on September 16 - 20, 2023, continuously for seven (7) calendar days.

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 975,067.74**.

WHEREAS, in response to the said advertisement/invitation, two (2) prospective bidders bought the Official Bid Documents at ₱1,000 each:

- 1. Orient Star Construction, Inc.
- 2. Giant MaPhil Construction

WHEREAS, the contractors/bidders submitted their bids in a sealed envelope within the published deadline;

WHEREAS, at 9:30 A.M. on 04 October 2023 the Technical Bids of ORIENT STAR CONSTRUCTION and GIANT MaPHIL CONSTRUCTION were opened and both passed the preliminary examination. After which, the Financial Bid were opened and also passed the preliminary examination and the result of their Financial Bids are tabulated as follows:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical/project and financial requirements submitted by GIANT MaPhil Construction, its bid has been found to be responsive pursuant to RA 9184 and its 2016 Revised IRR and Latest GPPB Issuances;

NOW THEREFORE, for and in consideration of the foregoing premises, the PMO-Palawan Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- 1. To declare GIANT Maphil Construction as the bidder with the Lowest Calculated Responsive Bid for the project MPF-PLW-04-2023 Maintenance of Various Port Physical Facilities, Port of Coron, Coron, Palawan;
- 2. To recommend for approval by the Port Manager/Head of the Procuring Entity (HOPE) of PMO- Palawan the foregoing findings; and
- 3. To recommend award of contract of the subject project to GIANT MaPhil Construction in its submitted bid amount of **Eight Hundred Twenty-Nine Thousand Forty-Seven Pesos and Fifty Centavos (Php 829,047.50).**
