**AMENDMENT FOR THE DECLARATION OF THE BID OF DBP SERVICE  
CORPORATION (DBPSC) AS THE SINGLE CALCULATED RESPONSIVE BID AND  
RECOMMENDING TO THE ACTING PORT MANAGER THE AWARD OF CONTRACT**

WHEREAS, the Bids and Awards Committee for the Procurement of Goods and Consultancy Services and for Engineering Projects (BAC-PGCSEP) posted the Invitation to Bid for the Procurement of Temporary Administrative and Technical Support Personnel of Philippine Ports Authority, PMO Palawan for Contract Period : July 1, 2018 until December 31, 2018 at the websites of Philippine Government Electronic Procurement System (PhilGEPS) with Bid Notice Abstract Reference No. 5354383 and Philippine Ports Authority (PPA), and PPA PMO-Palawan Bulletin Board continuously for seven (7) calendar days from May 18-24, 2018;

WHEREAS, in response to the said advertisement, one (1) firm, the DBP Service Corporation (DBPSC) purchased the bid documents;

WHEREAS, on 6 June 2018, DBPSC submitted its bid documents at 8:41 A.M. earlier than the prescribed period ;

WHEREAS, during the opening of bid documents on 6 June 2018 at 9:00 A.M., the Technical Component (First Envelope) was checked to determine the presence or absence of the eligibility and technical requirements, and DBP Service Corporation passed the eligibility check of the documents.

WHEREAS, the Financial Component (Second Envelope) of DBPSC was opened and checked to determine the presence or absence of documents required, and was rated "passed" considering its bid as "complete and complying", subject to detailed evaluation;

WHEREAS, the total Bid Price offered by DBPSC is shown below:

WHEREAS, on June 7, 2018, the BAC-Procurement of Goods and Consultancy Services and For Engineering Projects declared the submitted bid of DBP Service Corporation (DBPSC) in the amount of Four Million Nine Hundred Eighty-three Thousand One Hundred Ninety-Two Pesos & 48/100 (Php 4,983,192.48 ) as the single calculated bid, subject to post-qualification.

WHEREAS, the post-qualification was conducted by the BAC-PGCSEP TWG on June 9-11, 2018 and upon careful examination, validation and verification of all the eligibility, technical and financial statements and documents submitted, the BAC-PGCSEP has determined that DBPSC passed the post-qualification;

WHEREAS, the recommended amount per BAC Resolution No. 03-2018 was the Bid amount as calculated (P4,983,345.72) instead of the Bid Amount as read (P4,983,192.48), as the latter is lower;

WHEREAS, Sec. 34.4 of the 2016 Revised IRR of RA 9184 provides that, "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower";

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Procurement of Goods and Consultancy Services and for Engineering Projects (BAC-PGCSEP), hereby RESOLVE as it is hereby RESOLVED :


- a) To declare the submitted bid of DBP Service Corporation (DBPSC) in the amount of **Four Million Nine Hundred Eighty-Three Thousand One Hundred Ninety-Two Pesos & 48/100 (Php 4,983,192.48)** as the Single Calculated and Responsive Bid pursuant to Section 36 (a) of R.A. 9184 and its IRR, as revised for the Bidding of Temporary Administrative and Technical Support Personnel of Philippine Ports Authority, PMO Palawan for Contract Period : July 1, 2018 until December 31, 2018;
- b) To recommend to the Acting Port Manager the award of the Contract for the Procurement of Temporary Administrative and Technical Support Personnel of Philippine Ports Authority, PMO Palawan for Contract Period : July 1, 2018 until December 31, 2018.
