WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/ posted the Invitation to Bid for the project Provision of Movable Covered Walk, Port of Coron, Coron, Palawan in the PhilGEPS and PPA websites, and at bulletin board of PMO- Palawan continuously for eight (8) days from September 17- 24, 2018;
