Declaring as Failure the Bidding of the project MPF-05-PLW-2017 Maintenance of Various Port Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan

WHEREAS, the Philippine Ports Authority, PMO-Palawan advertised/posted the Invitation to Bid for the project MPF-05-PLW-2017 Maintenance of Various Port Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan in Phil-GEPS and PPA websites and at the bulletin board of PMO-Palawan continuously for seven (7) days from October 17 to 23, 2017;

WHEREAS, there were two (2) prospective bidders who purchased bid documents namely, BCT TRADING AND CONSTRUCTION on October 24, 2017 at 10:25 A.M. and RAK Trading and Construction on November 3, 2017 at 10:15 A.M., respectively;

WHEREAS, on November 3, 2017 at 2:57 P.M., BCT TRADING AND CONSTRUCTION submitted a letter expressing their intention to no longer participate in the bidding while the Bid Documents of RAK Trading and Construction was not received by the BAC until the deadline of submission of bid/s on November 7, 2017 at 8:30 A.M.;

NOW THEREFORE, for in consideration of the foregoing premises, the PMO-Palawan Bids and Award Committee hereby resolves, as it hereby resolves, to declare the Bidding of the MPF-05-PLW-2017 Maintenance of Various Port Physical Facilities, Port of Brooke's Point, Brooke's Point, Palawan a FAILURE;

RESOLVED FURTHER, to recommend to the Acting Port Manager of PMO-Palawan, the head of procuring entity, to conduct another competitive public bidding, as provided for under RA 9184 and its 2016 revised IRR, for the procurement of the contract of subject project.
