WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/posted the Invitation to Bid for the project MPF-PLW-06-2017 Maintenance of Main/Old Passenger Terminal Building, Port of Puerto Princesa, Palawan in the PhilGEPS and PPA websites and at the bulletin board of PMO-Palawan continuously for seven (7) days from October 17 to 23, 2017;

WHEREAS, the Approved Budget for the Contract to be Bid as published/ advertised/ posted is **P 2,568,706.55**;

WHEREAS, in response to said advertisement, three (3) prospective bidders secured the Bid Documents in the amount of **P 5,000.00**, namely:

- 1.) BCT TRADING AND CONSTRUCTIONJ
- 2.) ORIENT STAR CONSTRUCTION, INC.
- 3.) RAK TRADING AND CONSTRUCTION

WHEREAS, ORIENT STAR CONSTRUCTION, INC. submitted its bid in sealed envelope on November 6, 2017 at 1:40 P.M. while the Bid Documents of RAK TRADING AND CONSTRUCTION have not received by the BAC until the deadline of submission of bid/s on November 7, 2017 at 8:30 A.M.;

WHEREAS, BCT TRADING AND CONSTRUCTION submitted a letter on November 3, 2017 at 2:57 P.M. expressing their intention to no longer participate in the bidding and was read before the opening of bid/s;

WHEREAS, at 9:17 A.M. on November 07, 2017, the Technical Bid of ORIENT STAR CONSTRUCTION, was opened and passed the preliminary examination. After which, the Financial Bids was opened and also passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:
