## BIDS AND AWARD COMMITTEE FOR ENGINEERING PROJECTS Resolution No. 18 Series of 2017

Declaring the Bid of ORIENT STAR CONSTRUCTION INC. as the Single Calculated Responsive Bid for the project NRP-PLW-02-2017 Repair of Passenger Terminal/TMO Building, Port of El Nido, El Nido, Palawan and Recommending Approval Thereof and Recommending Award of Contract

WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/posted the Invitation to Bid for the project NRP-PLW-02-2017 Repair of Passenger Terminal/TMO Building, Port of El Nido, El Nido, Palawan in the PhilGEPS and PPA websites and at the bulletin board of PMO-Palawan continuously for seven days from November 1 to 7, 2017;

WHEREAS, the Approved Budget for the Contract to be Bid as published/ advertised/ posted is **P 3,605,540.86**;

WHEREAS, in response to said advertisement, three (3) prospective bidders secured the Bid Documents in the amount of **P 5,000.00**, namely:

- 1.) BCT TRADING AND CONSTRUCTIONJ
- 2.) MARYKNOLL BUILDERS & TRADING
- 3.) ORIENT STAR CONSTRUCTION, INC.

WHEREAS, the contractors/bidders submitted their bids in sealed envelope within published deadline;

WHEREAS, at 8:49 A.M. on November 21, 2017, the Technical Bid of MARYKNOLL BUILDERS & TRADING was opened and failed the Eligibility Requirement due to the following reasons:

- On Bid Form IX, (Breakdown of Major Categories of Work of Prospective Bidder's Completed Contract Similar to Contract to be Bid) the Similar Major Categories of Work required quantity (50% of BOQ) submitted for Item 1. "Masonry Works" and Item 3. "Painting Works" were insufficient.
- 2.) Non-submission of Certificates of Accomplishment of all on-going Government Contracts/Projects immediately after the Form X, (Statement of All On-Going Projects of Prospective Bidder).
- 3.) The bidder failed to show detailed computation of NFCC by substituting the values in the formula.



On Form X, (Statement of All On-Going Projects of Prospective Bidder) the bidder failed to submit updated project accomplishments of the following on-going Government Contracts/Projects that were previously used in the opening of bids for the project NCP-PLW-03-2017 Construction of Cargo/Transit Shed, Port of Culion, Culion, Palawan:
  - a. Impvt/Widening of F.B. Reyes (Busuanga Coron) Road K0011+(-387)-K0012+180;K0012+196.00-K0014+278.00, Coron, Palawan;
  - b. Impvt/Widening of F.B. Reyes (Busuanga-Coron) Road K0014+278.00-K0017+843.00, Coron, Palawan;
  - c. Const./Improvement of New-Quezon-Cheey-San Jose Decalachao Road to Busuanga Airport, Sta. 35+656.00-Sta. 39+800.00, Busuanga, Palawan, and
  - d. Dredging of Puerto Princesa Port, Puerto Princesa City
