**Resolution Declaring Failure of Bidding for the Emergency Maintenance of Port Operations Building Food Stalls, Port of Tubigon, Tubigon, Bohol**

WHEREAS, the Philippine Ports Authority, PMO-Bohol posted/published for three (3) continuous days the Request for Quotation and Invitation for Submission of Quotations on 03 December 2024 at the Philippine Ports Authority website, the PhilGEPS, and at the premises of the PPA, PMO-Bohol Administration Building, Tagbilaran City Hall and at the Bohol Provincial Capitol, the Emergency Maintenance of Port Operations Building Food Stalls, Port of Tubigon, Tubigon, Bohol;

WHEREAS, the BAC sent the Request for Quotation and Invitation for Submission of Quotations to three (3) suppliers of known qualifications through email on 03 December 2024;

WHEREAS, during the scheduled submission and opening of quotations on 06 December 2024 at 8:30 A.M., no suppliers submitted their quotations;

WHEREAS, Section 35, Rule X of the 2016 RIRR provides for the authority of the BAC to declare a failure of bidding when;

**Section 35. Failure of Bidding**

**35.1 The BAC shall declare the bidding a failure when:**

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification; and
- d) The bidder with LCRB, HRRB, SCRB, SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and the IRR.

WHEREAS, Section 35.2 of the 2016 RIRR, provides the condition on the declaration of failure of bidding which states that:

**Section 35.2** In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates;







