WHEREAS, opening of bids for the above project with Approved Budget for the Contract to be Bid (ABC) of One Million Nine Hundred Four Thousand Two Hundred Sixty Pesos and 82/100 (P 1,904,260.82) was conducted at the Conference Room, 2nd Floor- PPA Administration Building, Iloilo Commercial Port Complex, Iloilo City on December 15, 2020 at ten o' clock in the morning;


WHEREAS, **RRL Builders Corporation** was declared as lone bidder for the above stated project;


WHEREAS, after all documentary requirements for the first envelope were submitted, **RRL Builders Corporation** was declared eligible and evaluation of the Financial Documents revealed that **RRL Builders Corporation** has the single responsive bid of One Million Eight Hundred Ninety-nine Thousand One Hundred Thirty-Four Pesos and 95/100 (P 1,899,134.95) which is lower by the approved ABC;


NOW, THEREFORE, the PMO-Panay/Guimaras BAC-EP hereby resolves to declare the bid of **RRL Builders Corporation** as the single calculated responsive bid for "**Provision of Flagpole at PPA-PMO Panay/Guimaras Ports**", in the amount of **One Million Eight Hundred Ninety-nine Thousand One Hundred Thirty-Four Pesos and 95/100 (P 1,899,134.95)**.





"Provision of Flagpole at PPA-PMO Panay/Guimaras Ports"***


