BAC-EP RESOLUTION NO. 17-2016

A Resolution Recommending Award of Contract for "Proposed Container Van Office/Staff House at Port of Caticlan, Malay, Aklan" to the Single Calculated and Responsive Bidder

WHEREAS, Invitation to Bid for above project with Approved Budget for the Contract to be Bid (ABC) of Two Million, Ninety-Four Thousand, Five Hundred Twenty-Six Pesos (P2,094,526.00) was posted in the websites of PPA and PhilGEPS and at the PPA bulletin board for 7 calendar days starting 11 October 2016;

WHEREAS, in response to the above-mentioned posting, two (2) contractors purchased the bid documents; namely, *FLT Enterprises* and *Vannie Construction and Supply*;

WHEREAS, during the scheduled opening of bids on 02 November 2016, *FLT Enterprises* withdrew from the bidding for reason of time constraint; hence, declaring *Vannie Construction and Supply* as the *Single Calculated/Rated Bidder*;

WHEREAS, the bid tendered by *Vannie Construction and Supply* amounting to Two Million, Sixty-Three Thousand, Nine Hundred Twenty-Four Pesos and 41/100 (P2,063,924.41) was found lower than the ABC by 1.46%;

WHEREAS, post-evaluation of Financial Proposals revealed no changes in the bid offered by the *Single Calculated/Rated Bidder*;

WHEREAS, after post qualification of the submitted documents, taking into account it's a) legal; b) technical; c) experience; and d) contractor performance, equipment and financial requirements; the Committee found the lone Bidder to be sufficiently capable of undertaking and executing the project;

WHEREAS, Section 36 of the Revised IRR of RA 9184 on the *Single Calculated/Rated and Responsive Bid Submission* states;


"A single calculated/rated and responsive bid shall be considered for award if it falls under....

- a) *If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements...*


NOW, THEREFORE, the PMO-PNG BAC-EP hereby **RESOLVES** to recommend, as it is hereby recommended that **Vannie Construction and Supply** be awarded the contract for "**Proposed Container Van Office/Staff House at Port of Caticlan, Malay, Aklan**" in the amount of **Two Million, Sixty-Three Thousand, Nine Hundred Twenty-Four Pesos and 41/100 (P2,063,924.41)**.


