RECOMMENDING THE AWARD OF CONTRACT FOR  
THE "SUPPLY AND DELIVERY OF FRESHWATER FOR BASEPORT-ICPC, ILOILO  
FASTCRAFT TERMINAL, FORT SAN PEDRO AND PORT OF DUMANGAS FOR CY  
2019"

WHEREAS, after considering the bid tendered by HUC Merchandising for post-qualification as the Single Calculated Bid prescribed under Section 36 of R.A. 9184, it is found that the subject bidder is compliant;

WHEREAS, the submitted bid of HUC Merchandising is Three Million Two Hundred Ninety Two Thousand Twenty Pesos Only (P 3,292,020.00) as read;

WHEREAS, the subsequent detailed evaluation of bid shows no corrections on the bid amount as read;

WHEREAS, the calculated Bid is lower by 0.843% than the published Approved Budget for the Contract which is Three Million Three Hundred Twenty Thousand Pesos Only (Php 3,320,000.00);

WHEREAS, upon post qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with Single Calculated Bid (HUC Merchandising) the bid has been found to be responsive;

NOW, THEREFORE, upon motion of Engr. Joel A. Lamela and duly seconded by Ms. Emily D. Espeso, the COMMITTEE RESOLVES, as it is HEREBY RESOLVED

- a) To declare HUC Merchandising as the Bidder with Single Calculated Responsive Bid for the CONTRACT "SUPPLY AND DELIVERY OF FRESHWATER FOR BASEPORT-ICPC, ILOILO FASTCRAFT TERMINAL, FORT SAN PEDRO AND PORT OF DUMANGAS FOR CY 2019".
- b) To recommend for the approval of the award by the Acting Port Manager of PMO-Panay/Guimaras based on the above findings and declaration.
