**RESOLUTION No. 027, s. 2018**

**RECOMMENDING THE AWARD OF CONTRACT FOR  
THE "SUPPLY, DELIVERY AND INSTALLATION OF FOURTEEN (14) BRAND NEW  
AIRCONDITIONING UNITS, 2HP WINDOW TYPE AND NINE (9) BRAND NEW  
AIRCONDITIONING UNITS, 3-TONNER FLOOR MOUNTED, 230V, 1-PHASE  
(INVERTER TYPE)"**

WHEREAS, the bid tendered by NIG MARKETING CORP. as the Lowest Calculated Bid was declared non-responsive for not meeting the required Technical Specifications;

WHEREAS, after considering the bid tendered by EMCOR INC., for post-qualification as the 2<sup>nd</sup> Lowest Calculated Bid prescribed under Section 36 of R.A. 9184, it is found out that the subject bidder is compliant;

WHEREAS, the submitted bid of EMCOR INC. is ONE MILLION EIGHT HUNDRED FORTY FIVE THOUSAND EIGHT HUNDRED TWENTY NINE PESOS ONLY (Php 1,845,829.00) as read;

WHEREAS, the subsequent detailed evaluation of bid shows no corrections on the bid amount as read;

WHEREAS, the calculated Bid is lower by 9.9596% than the published Approved Budget for the Contract which is Two Million Fifty Thousand Pesos Only (Php2,050,000.00);


WHEREAS, upon post qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder as the 2<sup>nd</sup> Lowest Calculated Bid (EMCOR INC.) the bid has been found to be responsive;

NOW, THEREFORE, upon motion of ENGR. JOEL A. LAMELA and duly seconded by MS. DYAN S. DEADIO, the COMMITTEE RESOLVES, as it is HEREBY RESOLVED

- a) To declare EMCOR INC. Industrial Sales as the Lowest Calculated Responsive Bid for the CONTRACT "SUPPLY, DELIVERY AND INSTALLATION OF FOURTEEN (14) BRAND NEW AIRCONDITIONING UNITS, 2HP WINDOW TYPE AND NINE (9) BRAND NEW AIRCONDITIONING UNITS, 3-TONNER FLOOR MOUNTED, 230V, 1-PHASE (INVERTER TYPE)".

- b) To recommend for the approval of the award by the Port Manager of PMO-Panay/Guimaras based on the above findings and declaration.


