**RECOMMENDING THE AWARD OF CONTRACT FOR  
THE“PROCUREMENT OF ADMINISTRATIVE & TECHNICAL SERVICES,  
ENGINEERING SERVICES AND JANITORIAL & MAINTENANCE SERVICES  
THRU MANPOWER SERVICE PROVIDER FOR CY 2018”**

WHEREAS, after considering the bid tendered by LBP Service Corp. for post-qualification as the Single Calculated Bid prescribed under Section 36 of R.A. 9184, it is found that the subject bidder is compliant;

WHEREAS, the submitted bid of LBP Service Corp. is **Eleven Million, Three Hundred Thirty Four Thousand Four Hundred Sixty One Pesos & 40/100(₱ 11,334,461.40)** as read;

WHEREAS, the subsequent detailed evaluation of bid shows that the calculated bid price is **Eleven Million Three hundred Twenty Six Thousand Five Hundred Fifty-One & 24/100 (₱11,326,551.24)**;

WHEREAS, the calculated Bid is lower by 0.859% than the published Approved Budget for the Contract which is Eleven Million, Four Hundred Twenty Four Thousand, Seven Hundred Thirty Pesos and 67/100 (**Php11,424,730.67**);


WHEREAS, upon post qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with Single Calculated Bid (LBP Service Corp.) the bid has been found to be responsive;

NOW, THEREFORE, upon motion of Mrs. EMILY D. ESPESO and duly seconded by Mr. JOEL A. LAMELA, the COMMITTEE RESOLVES, as it is HEREBY RESOLVED


- a) To declare LBP Service Corporation as the Bidder with Single Calculated Responsive Bid for the CONTRACT “PROCUREMENT OF ADMINISTRATIVE & TECHNICAL SERVICES, ENGINEERING SERVICES AND JANITORIAL & MAINTENANCE SERVICES THRU MANPOWER SERVICE PROVIDER FOR CY 2018”.
