WHEREAS, the submitted bid of J.S Layson Co, Inc. is TWO MILLION SIXTY THOUSAND NINE HUNDRED SEVENTY SIX PESOS ONLY (Php 2,060,976.00) as read;

WHEREAS, the subsequent detailed evaluation of bid shows no corrections on the bid amount as read;


WHEREAS, the calculated Bid is lower by 0.0366% than the Approved Budget for the Contract which is TWO MILLION SIXTY ONE THOUSAND SEVEN HUNDRED THIRTY ONE & 40/100 Pesos (Php2,061,731.40);




