***A Resolution declaring the bid of RRL Builders Corporation as the single responsive bid for the project "Repair/Replacement of Damaged Rubber Dock Fenders and Mooring System at Port of Lipata, Culasi, Antique".***

**WHEREAS**, opening of bids for the above project with Approved Budget for the Contract to be Bid (ABC) of Six Million, Four Hundred Fifty Five Thousand, One Hundred Forty Two Pesos and 86/100 (P6, 455,142.86) was conducted at the Conference Room, 2nd Floor- PPA Administration Building, Iloilo Commercial Port Complex, Iloilo City on July 3, 2018 at nine o' clock in the morning;

**WHEREAS**, ***RRL Builders Corporation*** was declared as lone bidder for the above stated project;

**WHEREAS**, after all documentary requirements for the first envelope were submitted, ***RRL Builders Corporation*** was declared eligible and evaluation of the Financial Documents revealed that ***RRL Builders Corporation*** has the single responsive bid of Six Million, Four Hundred Twenty Five Thousand, Four Hundred Thirty-Four Pesos and 53/100 (P6, 425,434.53) which is lower by 0.46% of the approved ABC;

**NOW, THEREFORE**, the PMO-Panay/Guimaras BAC-EP hereby resolves to declare the bid of ***RRL Builders Corporation*** as the single calculated responsive bid for ***"Repair/Replacement of Damaged Rubber Dock Fenders and Mooring System at Port of Lipata, Culasi, Antique"***, in the amount of ***Six Million, Four Hundred Twenty Five Thousand, Four Hundred Thirty-Three Pesos and 66/100 (P6, 425,433.66)***.






