

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 08-11112016

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Oriental/Siquijor** advertised once the Invitation to Apply for Eligibility and to Bid of the **Repair of Scouring at Reclamation Area, Damaged Curtain Wall including, Mooring and Fendering System, Port of Siquijor, Siquijor (NRP-NOS-04-16)** with an **Approved Budget for the Contract (ABC) of ₱ 5,143,524.85** in newspaper of nationwide general circulation and posted the same in the **Philippine Ports Authority** website, PhilGEPS website and a conspicuous place at the following premises continuously for 7 days, to wit:
