

Bids and Awards Committee Resolution Declaring Lowest Calculated Responsive Bid and Recommending Approval

RESOLUTION NO. 021 – 2022 EP

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid of the **REPAIR AND REPAINTING OF PMO BUILDING AND PTB CR INCLUDING BREASTFEEDING AREA AND INTER-FAITH ROOM**, Port of Banago, Barangay Banago, Bacolod City, Negros Occidental with an ABC of **Php1,520,638.18** posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, only One (1) interested Bidder who submitted their bid document and it was found eligible during the opening of bids on November 07, 2022 with the following offer:


WHEREAS, the post qualification of the bidder with responsive Bid was conducted on November 08, 2022;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **REPAIR AND REPAINTING OF PMO BUILDING AND PTB CR INCLUDING BREASTFEEDING AREA AND INTER-FAITH ROOM**, Port of Banago, Barangay Banago, Bacolod City, Negros Occidental, has been found to be responsive.

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**,

- a.) To declare **KENBE CONSTRUCTION SUPPLY** as the Bidder with the Single Calculated and Responsive Bid for the **REPAIR AND REPAINTING OF PMO BUILDING AND PTB CR INCLUDING BREASTFEEDING AREA AND INTER-FAITH ROOM**, Port of Banago, Barangay Banago, Bacolod City, Negros Occidental;
- a) To award the Contract to **KENBE CONSTRUCTION SUPPLY** as the Contractor with the Single Calculated and Responsive Bid in the amount of **ONE MILLION FIVE HUNDRED EIGHTEEN THOUSAND TWO HUNDRED SEVENTY PESOS AND 33/100 (Php1,518,270.33) ONLY**, subject to existing rules and regulations; and;
- b) To recommend for approval by the Acting Port Manager of the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO the foregoing findings.
