

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. SVP06 - 2018

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **PULL-OUT OF GENERATING SET, Port of Banago, Brgy.
