



BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 001 - 2021

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid of the **VARIOUS MAINTENANCE OF PMO BUILDING, Port of Banago, Bacolod City** with an ABC of **Php2,402,088.92** posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, Only One (1) Bidder is interested and submit their bid documents and found eligible during the opening of bids on May 26, 2021 with the following offer:

WHEREAS, the post qualification of the Lowest Calculated Bid was conducted May 28, 2021;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder with the Lowest Calculated Bid, **MKU CONSTRUCTION AND SUPPLY**, its bid has been found to be responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**.

To declare **MKU CONSTRUCTION AND SUPPLY** as the Bidder with the lowest Calculated Responsive Bid for the **VARIOUS MAINTENANCE OF PMO BUILDING, Port of Banago, Brgy. Banago, Bacolod City, Negros Occidental**;

- a) To award the Contract to **MKU CONSTRUCTION AND SUPPLY** as the Contractor with the Single Calculated and Responsive Bid in the amount of **TWO MILLION THREE HUNDRED NINETY SIX THOUSAND TWO HUNDRED FORTY SIX AND 70/100 PESOS (Php2,396,246.70) ONLY**, subject to existing rules and regulations; and
- b) To recommend for approval by the Acting Port Manager of the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO the foregoing findings.
