RESOLUTION NO. 013 – 2022 SVP

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/BB (PMO-NBB) advertised the Invitation to Bid of the **PROCUREMENT OF SUPPLY AND DELIVERY OF SAFETY AND SECURITY SIGNAGES** with an ABC of **Php 350,000.00** in the websites of the Philippine Ports Authority website and the PhilGEPS as well as in conspicuous places continuously for 7 days particularly at the following places:

- 1) Negros Occidental Provincial Capitol Public Information Board
- 2) Bacolod City Hall Public Information Board at the Bacolod New Government Center, and at
- 3) PMO-NBB's Bulletin Board;

WHEREAS, in response to the said advertisements, Three (3) interested Bidders submitted their bid documents;

WHEREAS, of the three (3) interested bidders who submitted their bids only Two (2) Bidders were found eligible during the opening of bids on June 28, 2022 and the lowest bid was the following offer;

WHEREAS, upon post-qualification and/or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **OUTDOORMASTER, INC.**, has been found to be responsive.

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED,

- a.) To declare **OUTDOORMASTER, INC.** as the Bidder with the Lowest Calculated and Responsive Bid for the **PROCUREMENT OF SUPPLY AND DELIVERY OF SAFETY AND SECURITY SIGNAGES** for The PPA, PMO – Negros Occidental/BB, Banago Port Bacolod City, Negros Occidental;
- a) To award the Contract to **OUTDOORMASTER, INC.** as the Contractor with the Lowest Calculated and Responsive Bid in the amount of **THREE HUNDRED THIRTY TWO THOUSAND NINE HUNDRED PESOS (Php 332,900.00) ONLY**, subject to existing rules and regulations; and
- b) To recommend for approval by the Acting Port Manager of the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO the foregoing findings.
