

## BAC Resolution Declaring LCRB and Recommending Approval

### RESOLUTION NO. 003-2018

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **REPAIR/ REPLACEMENT OF ELECTRICAL SYSTEM (NRP-NBB-03-18), Port San Carlos, San Carlos City, Negros Occidental** posted the same in the Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:


