

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 002-2018

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **REPAIR / IMPROVEMENT OF WATER SYSTEM (NRP-NBB-02-18), Port of Banago, Bacolod City, Negros Occidental** posted the same in the Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED.


