

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 004-2018

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **REPAIR OF TMO BUILDING (NRP-NBB-04-18), Port Pulupandan, Pulupandan, Negros Occidental** posted the same in the Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:
