

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 007-2018

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **REPAIR / ASPHALT OVERLAY IN EXISTING CONCRETE PAVEMENT, Port of Banago, Banago Port, Bacolod City, Negros Occidental (NRP-NBB-07-18)**, posted the same in the Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, only Three (3) Bidders submitted Letter of Intent and purchased bid documents and only One (1) Bidder was found eligible during the opening of bids on July 24, 2018 with the following offer:


