

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 008-2018

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **REPAIR / REPLACEMENT OF STREETLIGHTS LAMP POST, Port of Banago, Banago Port, Bacolod City, Negros Occidental (NRP-NBB-08-18)**, posted the same in the Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, the post qualification of the Lowest Calculated Bid was conducted August 10, 2018.


