

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 009-2018

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **REPAIR / REPLACEMENT OF V – TYPE RUBBER DOCK FENDER, Port of San Carlos, San Carlos City, Negros Occidental (NRP-NBB-09-18)**, posted the same in Newspaper, Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED.
