

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. SVP08 - 2018

WHEREAS, the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO advertised once the Invitation to Bid of the REPAIR / REHABILITATION OF TWO (2) STOCKROOMS, Port of Pulupandan, Pulupandan Negros occidental (Small Value Procurement) posted the same in the Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:
