



**BAC Resolution Declaring LCRB and Recommending Approval**

**RESOLUTION NO. EP 005-2021**

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid of the **REPAIR / ASPHALT OVERLAY IN EXISTING PAVEMENT (PHASE 3)**, Port of San Carlos, San carlos City, Negros Occidental (**NRP-NBB-04-21**) with an ABC of Php 28,298,301.63 posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, Only One (1) Bidder was interested and submitted their bid documents and was found eligible during the opening of bids on September 13, 2021 with the following offer:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder with the Lowest Calculated Bid, **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.**, its bid has been found to be responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**.

- a.) To declare **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.** as the Bidder with the lowest Calculated Responsive Bid for the **REPAIR / ASPHALT OVERLAY IN EXISTING PAVEMENT (PHASE 3)**, Port of San Carlos, San Carlos City, Negros Occidental (NRP-NBB-04-21);
- b.) To award the Contract to **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.** as the Contractor with the Single Calculated and Responsive Bid in the amount of **TWENTY EIGHT MILLION TWO HUNDRED EIGHTY SEVEN THOUSAND SEVEN HUNDRED THIRTY SEVEN PESOS & 08/100 ONLY (Php28,287,737.08)**, subject to existing rules and regulations; and
- c.) To recommend for approval by the Acting Port Manager of the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO the foregoing findings.
