



BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. EP 006-2021

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid of the **REPAIR OF CHB FENCE, COVERED WALKWAY, RIPRAP/DEFLECTOR WALL AND MOORING SYSTEM**, Port of San Carlos, San Carlos City, Negros Occidental (NRP-NBB-05-21) with an ABC of Php19,935,036.75 posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, Only One (1) Bidder was interested and submitted their bid documents and was found eligible during the opening of bids on September 13, 2021 with the following offer:

WHEREAS, the detailed evaluation of bids was conducted on the same day September 13, 2021 and the result was as follows:

WHEREAS, the post qualification of the Lowest Calculated Bid was conducted on September 17, 2021;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder with the Lowest Calculated Bid, **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.**, its bid has been found to be responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED.

- a.) To declare **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.** as the Bidder with the lowest Calculated Responsive Bid for the **REPAIR OF CHB FENCE, COVERED WALKWAY, RIPRAP/DEFLECTOR WALL AND MOORING SYSTEM**, Port of San Carlos, San Carlos City, Negros Occidental (NRP-NBB-04-21);
- b.) To award the Contract to **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.** as the Contractor with the Single Calculated and Responsive Bid in the amount of **NINETEEN MILLION NINE HUNDRED TWENTY EIGHT THOUSAND SIX HUNDRED FIFTEEN PESOS & 06/100 ONLY (Php19,928,615.06)**, subject to existing rules and regulations; and
- c.) To recommend for approval by the Acting Port Manager of the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO the foregoing findings.




