

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 011-2018

WHEREAS, the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO advertised once the Invitation to Bid of the REPAIR OF RORO RAMP AT BERTH D, Port of Banago, Bacolod City, Occidental (NRP-NBB-11-18), posted the same in the Newspaper, Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:

1) Negros Occidental Provincial Capitol

2) City Hall, Bacolod City
