



**Bids and Awards Committee Resolution Declaring Lowest
Calculated Responsive Bid and Recommending Approval**

RESOLUTION NO. 020 – 2022 SVP

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid for the **AA ELECTRICAL SUPPLY** for the PMO-NBB with an ABC of **Php330,000.00** posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, there were Three (3) interested Bidders who submitted their bid document. Only One (1) Bidder was found eligible during the opening of bids on October 24, 2022 with the following offer:


WHEREAS, the post qualification of the bidder with responsive Bid was conducted on October 28, 2022;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED,

- a.) To declare **AA ELECTRICAL SUPPLY** as the Bidder with the Lowest Calculated and Responsive Bid for the **AA ELECTRICAL SUPPLY** for The PPA, PMO – Negros Occidental/BB, Banago Port Bacolod City, Negros Occidental;
- a) To award the Contract to **AA ELECTRICAL SUPPLY** as the Contractor with the Lowest Calculated and Responsive Bid in the amount of **THREE HUNDRED SEVEN THOUSAND FOUR HUNDRED PESOS (Php307,400.00) ONLY**, subject to existing rules and regulations; and
- b) To recommend for approval by the Acting Port Manager of the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO the foregoing findings.


