

## RESOLUTION NO. 012-2018

WHEREAS, the Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO advertised once the Invitation to Bid of the REPAIR / RETROFITTING OF PMO ADMINSTRATION BUILDING UNDERDECK, Port of Banago, Bacolod City, Occidental (NRP-NBB-12-18), posted the same in the Newspaper, Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:
