



**BAC Resolution Declaring LCRB and Recommending Approval**

**RESOLUTION NO. 012-2018**

WHEREAS, the **Philippine Ports Authority, Port Management Office – Negros Occidental/Bacolod/Banago-BREDCO** advertised once the Invitation to Bid of the **REPAIR / RETROFITTING OF PMO ADMINISTRATION BUILDING UNDERDECK, Port of Banago, Bacolod City, Occidental (NRP-NBB-12-18)**, posted the same in the Newspaper, Philippine Ports Authority website, PhilGEPS website and conspicuous places at the following premises continuously for 7 days, to wit:

- 1) Negros Occidental Provincial Capitol
- 2) City Hall, Bacolod City
- 3) Port Management Office – Negros Occidental/Banago/Bacolod-BREDCO Bulletin Board

WHEREAS, in response to the said advertisements, only One (1) Bidder submitted Letter of Intent and purchased bid documents and was found eligible during the opening of bids on September 24, 2018 with the following offer:


