



BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. EP 011-2021

WHEREAS, the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO advertised the Invitation to Bid of the **REPAIR OF RC PIER, RIPRAP AND RC BRIDGE AT CAUSEWAY**, Port of Banago, Bacolod City, Negros Occidental (NRP-NBB-03-21) with an ABC of Php30,120,843.75 posted in the Philippine Ports Authority website, the PhilGEPS and in the conspicuous places at the following premises continuously for 7 days, to wit:

WHEREAS, in response to the said advertisements, Only One (1) Bidder was interested and submitted their bid documents and was found eligible during the opening of bids on October 29, 2021 with the following offer:


WHEREAS, the post qualification of the Lowest Calculated Bid was conducted on November 04, 2021;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED;


- a.) To declare **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.** as the Bidder with the lowest Calculated Responsive Bid for the **REPAIR OF RC PIER, RIPRAP AND RC BRIDGE AT CAUSEWAY**, Port of Banago, Bacolod City, Negros Occidental (NRP-NBB-03-21);
- b.) To award the Contract to **GOLDRIDGE CONSTRUCTION AND DEV'T. CORP.** as the Contractor with the Single Calculated and Responsive Bid in the amount of **THIRTY MILLION ONE HUNDRED TEN THOUSAND ONE HUNDRED EIGHTY ONE PESOS & 59/100 ONLY (Php30,110,181.59)**, subject to existing rules and regulations; and
- c.) To recommend for approval by the Acting Port Manager of the Philippine Ports Authority, Port Management Office - Negros Occidental/Bacolod/Banago-BREDCO the foregoing findings.
