



BAC Resolution Declaring Single Calculated Responsive Bid, Recommending Approval and Issuance of Notice of Award

RESOLUTION NO. 002 – 2021

WHEREAS, the Philippine Ports Authority, Port Management Office – Western Leyte/Biliran posted the Invitation to Bid (IB) for the **Supply and Delivery including Setup/Installation of Furniture and Fixtures for the Port Operation Building, PMO Western Leyte/Biliran** in the PhilGEPS website, PPA website and in conspicuous places from March 24, 2021 to April 19, 2021.

WHEREAS, in response to the said advertisements, three (3) prospective bidders showed their intent join;

WHEREAS, two (2) of the three prospective bidders, namely PENITON TRADING and VEDULA ENTERPRISES INC., requested for the alternative online payment procedure on the purchase of the bidding documents;

WHEREAS, after they were immediately provided alternative online payment procedure, no payment was confirmed from PENITON and VEDULA;

WHEREAS, before the deadline for submission of bids only **one (1)** prospective bidder purchased bidding documents and submitted their bid;

WHEREAS, the bid submitted by the Lone Bidder was found to be complying;


