"A RESOLUTION APPROVING AND CONCURRING THE RECOMMENDATION AND RESULTS OF THE DETAILED BID EVALUATION AND POST-QUALIFICATION OF BIDS CONDUCTED BY THE BAC-PGS TECHNICAL WORKING GROUP"

Resolution No. 21, Series of 2016

(Excerpts from the Meeting, in re: Results of the Detailed Bid Evaluation and Post-Qualification conducted by the Technical Working Group dated 28 September 2016)

WHEREAS, after two (2) failed public bidding for this project, the BAC-PGS per recommendation and as duly approved by the Port Manager as Head of Procuring Entity (HOPE), resorted to Alternative Method of Procurement thru Negotiated Procurement pursuant to Sec. 53 of the Revised IRR of RA 9184;

WHEREAS, Letter-Request for Proposal/Submission of Price Quotation was sent to accredited prospective bidder/supplier, and an Invitation to Bid was posted at PPA and PhilGEPS Website dated 01 September 2016, of the Contract for the Supply, Delivery, Installation, Testing and Commissioning of Automatic Identification System (AIS) for the Ports of Cagayan de Oro, Benoni, Guinsiliban and Balingoan, and at Sulawan Point, Alubijid, Misamis Oriental, and Training of End-User Personnel, thru public bidding with an ABC of Php. 1,100,510.00;

WHEREAS, the BAC-PGS convened on 5 September 2016 to conduct a Pre-bid Conference to ensure compliance with the standards set forth in Sec. 22 of the Revised IRR of RA 9184, however, no bidder attended the said conference;

WHEREAS, on the scheduled Opening of Bids dated 09 September 2016, no bid submitted by Marick Corporation, rather, sent a letter thru email informing the BAC that their Tax Clearance Certificate is still on process. Accordingly, the BAC-PGS declared there was a "Failure" of bidding;

WHEREAS, the BAC-PGS convened on 22 September 2016 to discuss among others the updates in regard the procurement of Automatic Identification System (AIS) and the lacking documentary requirement of the lone prospective bidder (Marick Corporation);

WHEREAS, an Invitation to Bid was posted at PPA and PhilGEPS Website dated 23 September 2016, of the Contract for the Supply, Delivery, Installation, Testing and Commissioning of Automatic Identification System (AIS) for the Ports of Cagayan de Oro, Benoni, Guinsiliban and Balingoan, and at Sulawan Point, Alubijid, Misamis Oriental, and Training of End-User Personnel, thru public bidding with an ABC of One Million One Hundred Thousand Five Hundred Ten Pesos (Php. 1,100,510.00);

WHEREAS, during the Opening of Bids dated 27 September 2016, Marick Corporation submitted its Bid, with a Financial Offer of One Million One Hundred Thousand Five Hundred Ten Pesos (Php. 1,100,510.00), as read, has subjected to a Detailed Evaluation/Examination of Bids to objectively consider the completeness of the bid and arithmetical corrections, and subsequently, underwent post-qualification process;





WHEREAS, in a meeting scheduled in herein date, the TWG presented its Detailed Bid Evaluation and Post-Qualification Report to the BAC, and accordingly recommended the following:

> "Based on the result of the Detailed Bid Evaluation pursuant to Section 30 of the Revised IRR of Republic Act No. 9184, the TWG respectfully recommends that Marick Corporation with a re-calculated bid price of One Million One Hundred Thousand Five Hundred Ten in Philippine Currency (Php. 1,100,510.00) is the Single Calculated and Responsive Bid. "

WHEREFORE, in consideration of the foregoing, the BAC-PGS RESOLVED AS IT IS HEREBY RESOLVES to declare the bid of Marick Corporation as the Single Calculated and Responsive Bid with calculated amounted of One Million One Hundred Thousand Five Hundred Ten in Philippine Currency (Php. 1,100,510.00);

RESOLVED FURTHER, to respectfully recommend to the Head of Procuring Entity to grant the award of the Contract to the said bidder, and correspondingly issue a Notice of Award pursuant to Section 36 of the Revised IRR of RA 9184.

RESOLVED UNANIMOUSLY on 28 September 2016 at the Conference Room of PMO-Misamis Oriental/Cagayan de Oro.
