**“A RESOLUTION DECLARING EC STRUCTURAL COMPOSITES, INC. AS THE SINGLE
CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT RETROFITTING OF
R.C. PILES, PILE CAPS, AND BEAMS AT EASTERN WHARF, PORT OF GENERAL
SANTOS, MAKAR WHARF, GENERAL SANTOS CITY”**

WHEREAS, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Retrofitting of R.C. Piles, Pile Caps, and Beams at Eastern Wharf, Port of General Santos, Makar Wharf, General Santos City with an Approved Budget for the Contract (ABC) of **Twenty-Nine Million Six Hundred Eighty-Nine Thousand Two Hundred Sixty-Seven Pesos Only (P 29,689,267.00)** only;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, the said Invitation to Bid was also published in the Philippine Star;

WHEREAS, in response to the said publication and posting requirement, three (3) bidders procured the bidding documents namely EC Structural Composites, Inc., Teddie Construction Development, Inc., and A.I.Yu Builders and Enterprises;

WHEREAS, two of the bidders namely Teddie Construction Development, Inc. and A.I.Yu Builders and Enterprises submitted their letter of withdrawal prior to the deadline of submission of bids;

WHEREAS, only one (1) bidder successfully dropped its bid;

WHEREAS, IN Resolution No. 2 Series of 2017 dated April 11, 2017, the BAC-EP declared EC Structural Composites, Inc. as Single Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC-EP on April 17 to April 18, 2017;


WHEREAS, the TWG, during the April 19, 2017 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by EC Structural Composites, Inc.;

NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is **RESOLVED**:


- a) To declare EC Structural Composites, Inc. as the Single Calculated and Responsive Bidder for the project Retrofitting of R.C. Piles, Pile Caps, and Beams at Eastern Wharf, Port of General Santos, Makar Wharf, General Santos City with the bid amount of ***Twenty-Eight Million Five Hundred Thousand Nine Hundred Ninety-Two and 66/100 Pesos (Php 28,500,992.66);***
- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award.
