**“A RESOLUTION DECLARING AIYU BUILDERS & ENTERPRISES AS THE SINGLE
CALCULATED BIDDER FOR THE PROJECT REPAIR AND REPLACEMENT OF DAMAGED
EXISTING SLOPE PROTECTION, CONCRETE PAVEMENT AND RC CURB, PORT OF
GLAN, GLAN, SARANGANI PROVINCE”**

WHEREAS, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Repair and Replacement of Damaged Existing Slope Protection, Concrete Pavement and RC Curb, Port of Glan, Glan, Sarangani Province with an Approved Budget for the Contract (ABC) of **Twenty Seven Million Five Hundred Sixty Five Thousand Nine Hundred Thirty Five Pesos Only (P 27,565,935.00) Inclusive of 12% VAT** only;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, the said Invitation to Bid was published at the Philippine Star, a national newspaper, on April 10, 2017;

WHEREAS, in response to the said publication and posting requirement, Three (3) bidder procured the bidding documents namely AIYU Builders & Enterprises, Khan Kon Chi Construction and YSL Builders;

WHEREAS, bidders AIYU Builders & Enterprises and Khan Kon Chi Construction successfully dropped its bid on time;

WHEREAS, bidder YSL Builders submitted a letter of withdrawal;

WHEREAS, upon opening of bid documents, Khan Kon Chi Construction failed in their technical documents;

WHEREAS, upon opening the eligibility, technical and financial bid proposal, AIYU Builders & Enterprises passed the complete documentary requirement, to wit:


WHEREAS, the bid of AIYU Builders & Enterprises did not exceed the ABC.

- a) To declare AIYU Builders & Enterprises as the Single Calculated Bidder for the project Repair and Replacement of Damaged Existing Slope Protection, Concrete Pavement and RC Curb, Port of Glan, Glan, Sarangani Province with the bid amount of Twenty Six Million Seven Hundred Thirty Eight Thousand Nine Hundred Fifty Six and 95/100 Pesos (**Php 26,738,956.95**);
- b) To direct the Technical Working Group to conduct Post Qualification on May 5 to 6, 2017.

RESOLVED, at the Philippine Ports Authority, PMO SOCSARGEN this 3rd day of May 2017.


