WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project "ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 1: (1) REPAINTING OF GI CHAINS, SHACKLES AND ACCESSORIES AT RORO AND NEWLY CONSTRUCTED WHARF AND REPAINTING OF BOLLARDS ALONG CAL.000-851; (2) REPAIR OF SETTLED PAVING BLOCKS AT CY1 & CY3; (3) REPAIR OF CHB PERIMETER FENCE AT HOLCIM AREA, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY" with an Approved Budget for the Contract (ABC) of Nine Hundred Twelve Thousand Seven Hundred Seventy-Nine Pesos and 95/100 Only (Php912,779.95) Inclusive of 5% VAT;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board in accordance with the Revised Implementing Rules and Regulations (IRR) on Republic Act (RA) 9184;

WHEREAS, in response to the said posting requirement, three (3) bidders procured the bidding documents namely: (1) Winch Mechanical Innovations & General Construction, Inc., (2) RPE Engineering Procurement Construction and Management, and (3) MCS Builders;

WHEREAS, a set of observers including a representative from COA was duly invited to the Pre-Bid Conference, Opening of Bids, and Post-Qualification activities;

WHEREAS, on the Pre-bid Conference conducted, the bidding documents containing the eligibility requirements, technical and financial components of the bid were discussed, clarified, and explained to prospective bidders;

WHEREAS, one (1) bidder submitted a letter of non-participation to the bidding process, namely RPE Engineering Procurement Construction and Management;

WHEREAS, before the deadline of the submission of bids, there were two (2) bidders who successfully dropped their bid on time, namely:(1) Winch Mechanical Innovations & General Construction, Inc. and (2) MCS Builders;

WHEREAS, on the scheduled opening of bids, the BAC conducted a preliminary examination of bids using the checklist of required documents and following the non-discretionary "pass/fail" criterion in accordance with Section 30.1 and 30.2 of the Revised IRR of RA 9184;

WHEREAS, after the preliminary examination of bids, the BAC ascertained and rated the following bidders:
