WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project *REPAIR OF DAMAGED PAVING BLOCKS AT CONTAINER YARD 3 PHASE 2, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY* with an Approved Budget for the Contract (ABC) of Eighteen Million Nine Hundred Seventy Seven Thousand One Hundred Forty Seven Pesos Only (P 18,977,147.00) Inclusive of 12% VAT;

WHEREAS, the said Invitation to Bid was publish in the Philippine Star on May 25, 2018;

WHEREAS, the said Invitation to Bid was also posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, in response to the said posting requirement, one (1) bidder procured the bidding documents namely Zet Construction

WHEREAS, the said bidder successfully dropped its bid on time;

WHEREAS, during the opening and evaluation of bids, the bidder passed the complete documentary requirements, to wit:

WHEREAS, the bid of Zet Construction did not exceed the ABC.


NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:

- a) To declare Zet Construction as the Single Calculated Bidder for the project *REPAIR OF DAMAGED PAVING BLOCKS AT CONTAINER YARD 3 PHASE 2, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY* with the bid amount of Eighteen Million Nine Hundred Twenty Six Thousand Two Hundred Eighty Four Pesos and 78/100 (**Php18,926,284.78**) inclusive of 12% VAT;
- b) To direct the Technical Working Group to conduct Post Qualification on June 20 to 22, 2018.
