“A RESOLUTION DECLARING YSL BUILDERS AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT RE-BLOCKING OF ACCESS ROAD ALONG MAIN GATE TO WESTERN WHARF AND OPEN STORAGE AREAS 1 & 2, INFRONT & BACK PORTION OF PCG COMPOUND, & INFRONT OF PRE-FAB BUILDING, INCLUDING SLOPE CORRECTION & INSTALLATION OF SWING GATE THRU HOLCIM COMPOUND, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY”

WHEREAS, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Re-Blocking of Access Road along Main Gate to Western Wharf and Open Storage Areas 1 & 2, Infront & Back Portion of PCG Compound, & Infront of Pre-Fab Building, Including Slope Correction & Installation of Swing Gate Thru Holcim Compound, Port of General Santos, Makar Wharf, General Santos City with an Approved Budget for the Contract (ABC) of **Twenty One Million Four Hundred Sixty Four Thousand Five Hundred Thirty Three Pesos Only (P 21,464,533.00) Inclusive of 12% VAT only;**

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, the said Invitation to Bid was also published in the Philippine Star;

WHEREAS, in response to the said publication and posting requirement, three (4) bidders procured the bidding documents namely, A.I.Yu Builders and Enterprises, YSL Builders, Khan Kon Chi Construction, and KGD Builders;

WHEREAS, one of the bidders namely A.I.Yu Builders and Enterprises submitted their letter of withdrawal prior to the deadline of submission of bids;

WHEREAS, three (3) bidders successfully dropped its bid namely Khan Kon Chi Construction, YSL Builders, and KGD Builders;

WHEREAS, the Khan Kon Chi Construction failed to comply the requirements under the Instruction to Bidders;

WHEREAS, upon opening of bid documents, KGD Builders failed in their technical documents;

WHEREAS, IN Resolution No. 9 Series of 2017 dated August 1, 2017, the BAC-EP declared YSL Builders as Single Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC-EP on May 3 and May 4, 2017;

WHEREAS, the TWG, during the August 7, 2017 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by YSL Builders;


NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is **RESOLVED**:


- a) To declare YSL Builders as the Single Calculated and Responsive Bidder for the project Re-Blocking of Access Road along Main Gate to Western Wharf and Open Storage Areas 1 & 2, Infront & Back Portion of PCG Compound, & Infront of Pre-Fab Building, Including Slope Correction & Installation of Swing Gate Thru Holcim Compound, Port of General Santos, Makar Wharf, General Santos City with the bid amount of ***Nineteen Million Five Hundred Thirty-Two Thousand Four Hundred Fifty-Six and 40/100 (Php 19,532,456.40);***


- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award.


