**"A RESOLUTION DECLARING WCCERVANTES BUILDERS, INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE
PROJECT RE-BLOCKING OF ACCESS ROAD BETWEEN BERTH # 9 AND
CONTAINER YARD 4 INCLUDING REPAIR OF ELECTRICAL MANHOLE COVER,

WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project **RE-BLOCKING OF ACCESS ROAD BETWEEN BERTH # 9 AND CONTAINER YARD 4 INCLUDING REPAIR OF ELECTRICAL MANHOLE COVER, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY** with an Approved Budget for the Contract (ABC) of Five Million Sixty-One Thousand Seven Hundred Sixty Pesos and 79/100 Only (P 5,061,760.79) Inclusive of 12% VAT;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, in response to the said posting requirement, two (2) bidders procured the bidding documents namely: WCCervantes Builders, Inc. and MJ Tiongson Construction;

WHEREAS, two (2) bidders successfully dropped its bid on time namely: WCCervantes Builders, Inc. and MJ Tiongson Construction;

WHEREAS, in a Resolution No. 18 Series of 2019 dated October 1, 2019, the BAC declared WCCervantes Builders, Inc. as Single Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC on October 2-4, 2019;

WHEREAS, the TWG, during the October 7, 2019 post qualification meeting of the BAC, reported its validation and confirmation of the legal, technical and financial requirements submitted by WCCervantes Builders, Inc;


NOW, THEREFORE, We the members of the Bids and Awards Committee hereby **RESOLVED** as it is hereby **RESOLVED**:




