“A RESOLUTION DECLARING RIEZL LANDCARE AND CONSTRUCTION AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT CONSOLIDATED REPAIR AND MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT: 1.) REPAINTING OF CYCLONE FENCE NEAR NORTH GATE & CY IV, PM'S QUARTER PERIMETER FENCE, AND STEEL GRATING AND MANHOLE; 2.) SUPPLY, FABRICATION, AND INSTALLATION OF PPA LOGO; 3.) REPAIR OF DAMAGED CHB FENCE NEAR KENRAM OIL DEPOT; 4.) RENOVATION OF PM'S KITCHEN AND COMFORT ROOM, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY”

WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project *CONSOLIDATED REPAIR AND MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT: 1.) REPAINTING OF CYCLONE FENCE NEAR NORTH GATE & CY IV, PM'S QUARTER PERIMETER FENCE, AND STEEL GRATING AND MANHOLE; 2.) SUPPLY, FABRICATION, AND INSTALLATION OF PPA LOGO; 3.) REPAIR OF DAMAGED CHB FENCE NEAR KENRAM OIL DEPOT; 4.) RENOVATION OF PM'S KITCHEN AND COMFORT ROOM, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY* with an Approved Budget for the Contract (ABC) of *Two Million Five Hundred Ninety Nine Thousand Three Hundred Fifty Six Pesos Only (P 2,599,356.00) Inclusive of 12% VAT*;

WHEREAS, the said Invitation to Bid was also posted at PhilGEPS, PPA Website, and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, in response to the said posting requirement, three (3) bidders procured the bidding documents, namely RIEZL Landcare and Construction, Freden Construction, and MICAH Construction and Supply;

WHEREAS, the said bidders successfully dropped their bids on time;

WHEREAS, in a Resolution No. 20-EP Series of 2018 dated November 6, 2018, the BAC declared RIEZL LANDCARE AND CONSTRUCTION as Lowest Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC on November 8 - 9, 2018;

WHEREAS, the TWG, during the November 13, 2018 meeting of the BAC, reported its validation and confirmation of the legal, technical and financial requirements submitted by RIEZL LANDCARE AND CONSTRUCTION;

NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:

- a) To declare RIEZL LANDCARE AND CONSTRUCTION as the Lowest Calculated and Responsive Bidder for the project *CONSOLIDATED REPAIR AND MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT: 1.) REPAINTING OF CYCLONE FENCE NEAR NORTH GATE & CY IV, PM'S QUARTER PERIMETER FENCE, AND STEEL GRATING AND MANHOLE; 2.) SUPPLY, FABRICATION, AND INSTALLATION OF PPA LOGO; 3.) REPAIR OF DAMAGED CHB FENCE NEAR KENRAM OIL DEPOT; 4.) RENOVATION OF PM'S KITCHEN AND COMFORT ROOM, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY* with the bid amount of *TWO MILLION FOUR HUNDRED THOUSAND SEVEN HUNDRED EIGHTY-TWO PESOS AND 58/100 (Php 2,400,782.58) inclusive of 12% VAT*;
- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award.
