**“A RESOLUTION DECLARING EC STRUCTURAL COMPOSITES, INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE
PROJECT RETROFITTING OF REINFORCED PILES, SLAB AND BEAMS OF
BENT 1-26, INCLUDING PILES OF THE 11 UNITS BREASTING DOLPHINS,
PORT OF KALAMANSIG, KALAMANSIG, SULTAN KUDARAT”**

WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project **RETROFITTING OF REINFORCED PILES, SLAB AND BEAMS OF BENT 1-26, INCLUDING PILES OF THE 11 UNITS BREASTING DOLPHINS, PORT OF KALAMANSIG, KALAMANSIG, SULTAN KUDARAT** with an Approved Budget for the Contract (ABC) of Nineteen Million Eight Hundred Sixty-Six Thousand Five Hundred Ninety-Three Pesos and 97/100 Only (P 19,866,593.97) Inclusive of 12% VAT;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, in response to the said posting requirement, two (2) bidders procured the bidding documents namely: CCK Builders and Construction Supply and EC Structural Composites, Inc.;

WHEREAS, one (1) bidder successfully dropped its bid on time namely: EC Structural Composites, Inc.;

WHEREAS, in a Resolution No. 26 Series of 2019 dated November 21, 2019, the BAC declared EC Structural Composites, Inc. as Single Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC on November 24-25, 2019;

WHEREAS, the TWG, during the November 27, 2019 post qualification meeting of the BAC, reported its validation and confirmation of the legal, technical and financial requirements submitted by EC Structural Composites, Inc.;


NOW, THEREFORE, We the members of the Bids and Awards Committee hereby **RESOLVED** as it is hereby **RESOLVED**:
