**"A RESOLUTION DECLARING AIYU BUILDERS & ENTERPRISES AS THE SINGLE
CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT EMERGENCY REPAIR OF
SETTLED BACK-UP AND MANEUVERING AREAS AND CONCRETE PAVEMENT
DAMAGED BY MAGNITUDE 7.2 EARTHQUAKE, PORT OF GLAN, GLAN, SARANGANI
PROVINCE"**

WHEREAS, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Emergency Repair of Settled Back-Up and Maneuvering Areas and Concrete Pavement Damaged by Magnitude 7.2 Earthquake, Port of Glan, Glan, Sarangani Province with an Approved Budget for the Contract (ABC) of **Five Million Nine Hundred Eighty-Eight Thousand Seven Hundred Seventy-Six Pesos and 61/100 Only (P 5,988,776.61) Inclusive of 12% VAT** only;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, in response to the said publication and posting requirement, One (1) bidder procured the bidding documents namely AIYU Builders & Enterprises;

WHEREAS, the bidder AIYU Builders & Enterprises successfully dropped its bid on time;

WHEREAS, IN Resolution No. 17 Series of 2017 dated December 4, 2017, the BAC-EP declared YSL Builders as Single Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC-EP on December 5 - 8, 2017;

WHEREAS, the TWG, during the December 11, 2017 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by AIYU Builders & Enterprises;

NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is **RESOLVED**:

- a) To declare AIYU Builders & Enterprises as the Single Calculated and Responsive Bidder for the project Emergency Repair of Settled Back-Up and Maneuvering Areas and Concrete Pavement Damaged by Magnitude 7.2 Earthquake, Port of Glan, Glan, Sarangani Province with the bid amount of **Five Million Four Hundred Forty-Nine Thousand Eight Hundred Sixteen and 62/100 Pesos (Php 5,449,816.62)**;


- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award.
