WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Delivery of Two (2) Units Waterproof/Fogproof of Binoculars for PPA, PMO-Zamboanga, Zamboanga City starting December 3, 2019 until December 11, 2019 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;
