**BAC Resolution Declaring Single Calculated and Responsive Bid (LCRB) and
Recommending Approval**

RESOLUTION NO. 002-2017

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga advertised the Invitation to Bid of the Outsourcing of Janitorial Services of PMO-Zamboanga for CY 2017 in the Philippine Government Electronic Procurement System (PhilGEPS) Website, PPA Website and conspicuous place at the premises of the Philippine Ports Authority, PMO-Zamboanga continuously for 7 days on 03 February 2017;

WHEREAS, in response to the said advertisements, one (1) contractor in the name of LBP Service Corporation (LBPSC) submitted a Letter of Intent (LOI) and purchased the bid documents during the prescribed schedule;

WHEREAS, a Pre-Bid Conference was held on 10 February 2017 at 3:00 PM to solicit issues and concerns from the bidder before the finalization/submission of their Bid documents;


