

BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. CVP-11- 2024

One (1) Lot Supply of Manpower, Tools/Equipment for the Siphoning/Desludging and Disposal of 10–Unit Septic Tank/Vault of PPA, PMO-Zamboanga, Zamboanga City, with an ABC of Php969,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Manpower, Tools/Equipment for the Siphoning/Desludging and Disposal of 10–unit Septic Tank /Vault of PPA, PMO-Zamboanga, Zamboanga City, with an ABC of Php969,000.00 on May 2-9, 2024 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement was conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to four (4) suppliers, namely: Christine Haresco Wastewater Treatment Services, Terrain Shaper Construction and Enterprise, J-U Septic Tank Excavator & Plumbing Services and Roger's Septic Tank Cleaner;

WHEREAS, on May 9, the BAC opened the sealed price quotations envelopes of the invited suppliers, only two (2) out of the four (4) have submitted their quotation envelopes. Additionally, two other suppliers submitted their quotations via email namely; JPJ Sewerage Services and EMMB Construction & Supplies on May 8 and 9, respectively;

WHEREAS, during the bid evaluation meeting held on May 10, 2024, it was found out that the Instructions to Suppliers was lacking. Pertinent provisions from RA 9275 Clean Water Act and other legal requirements as may be deemed necessary, should be reviewed and included in the Instructions to Suppliers;

NOW THEREFORE, We, the Members of the PMO Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

To declare a failure of bidding for the project One (1) Lot Supply of Manpower, Tools/Equipment for the Siphoning/Desludging and Disposal of 10–unit Septic Tank /Vault of PPA, PMO-Zamboanga, Zamboanga City, with an ABC of Php969,000.00, and will be subject to reposting which is scheduled after the conduct of a BAC special meeting on May 20, 2024. The End-User is advised to review and to include the Instructions to Suppliers on the legal requirements for special projects.

To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
